



STATE ARREST DATA

NOTICE

In analyzing the statistics supplied in the 1997 Crime in Kentucky, it is important to note the extenuating circumstances which have caused a variance in the 1996 and 1997 data vs. previously supplied data. Due to severe weather-related computer problems experienced by Kentucky State Police (KSP), we have been unable to produce arrest information for 1996 or 1997. The Administrative Office of the Courts (AOC) cooperated with this agency by providing arrest data for these two years from their court records. You will not be able to compare the arrest data provided in the 1996 or 1997 publications to what was published by KSP in prior years since it was gathered in an entirely different manner.

There will be no large discrepancy in comparing the Part I data (violent crimes) to that of previous years, since it is collected similarly by both AOC and Kentucky State Police; however, the Part II numbers provided by AOC for 1996 and 1997 will vary considerably from those published by KSP in prior years. This can be attributed to the fact that arrest data published prior to 1996 reflected actual counts of individuals arrested within a given year, based on reports submitted to KSP from various police agencies. The data provided by AOC is derived solely from matters presented before the court. The difference lies in the fact that many such matters may be taken before the court system, such as those reported by the victim directly to the court, which never involved a law enforcement agency or actual arrest (charged but not arrested). Examples of these instances could include bad checks, juvenile matters, criminal mischief, minor thefts, vandalism, etc. This may also explain a significant difference in the juvenile data shown as opposed to prior years published data. If you require a county-by-county breakdown of juvenile arrests for 1996 (data also provided by AOC) to make comparisons against the 1997 juvenile arrest data printed in this publication, please phone our statistical office at (502)227-8700, ext. \8259.

We apologize for any inconvenience that this situation may have caused our users of Crime In Kentucky. We have made every attempt to present available arrest data in a manner which will allow at least one year of analysis.
